**Results:**

The results for Novice(A), Junior and Senior will be calculated according to ISU Regulations. Chicks – Debs (A Class) will be calculated according to Estonia Figure Skating Union Adapted Classification for Youngers for season 2009/2010 (attached in Appendix 1). All B Class categories will be calculated according to „B Group Classification of Estonian Figure Skating Union for season 2009/2010“ (2nd part of Appendix 1) using „6.0“ judging system.

**Registration of entries:**

All Clubs and member federations are invited to take part in this competition. Each Club / Federation may register athletes in any class and category, but the Organizing Committee have right to limit entries. Entry must be done in a written (according to included appendixes) form and sent to the OC by the E-mail or any other method. Please see Appendix 2. All A Class participants must fill "Planned Program Content Form" which you can find in Appendix 3 (It's mandatory). Entries information must be sent to the following person in the OC.

**Deadline of entries:**

**Entry fee:**

A group Chicks–Debs – 50 EUR

A group Novice–Junior – 60 EUR.

- Each club should pay entry fee with one transaction for all participants.
- In case the payment hasn't been done on time OC has right to withdraw unpaid participants from entry list.
- In case of participants cancelation (any reason), participating team can replace him with another participant in same category and class.
- OC will not refund the entry fee because of entry cancelation (excepting medical certificates).
- Participating teams should inform of any changes in their team as soon as possible, but not later than **February 1, 2010**.

**Music:**

Music must be recorded on CDs by **normal speed**. Music records must be signed with the full name of the competitor, his category, name of the club and nation.

### **Protest:**

Each team has the right to submit protest against the judges decision. Protest must be submitted to the Referee of the relevant at the latest immediately after the event. Upon the submission of the protest a protest fee of 30 EUR must be paid. The referees decision is final. In the new ISU judging system no protests can be filed against the judges, but against the right determination of the executed element. All protest must be summated according to Rule 123!

### **Awards:**

The three best placed competitors of each category will be awarded by medals. All competitors will get diplomas and special gifts.

### **Liability:**

In accordance with ISU Rule 119, the Organizer accepts no liability for injury or for property loss or damage incurred by Competitors or Officials. Each club is expected to provide its own insurance protection.

### **Expenses:**

The Organizer does not pay any expenses of the teams. Travel expenses, board and accommodation will be borne by the participants and their teams.

### **Judges:**

The participating clubs may propose a judge, at least qualified as international judge. The names of candidates should be forwarded to the Organizer. In case of too many judges entries, organizer will draw them. List of panels will be available at the organizers homepage

### **Accommodation:**

The Organizer shall not deal with accommodation.
